The COSUAA room rates vary from \$189 to \$227 per night and the hotel will honor the rate for up to three days before or after the conference for those that wish to extend their stay. The deadline to reserve a room at the conference rate is **March 27, 2018**. The King and Prince sits right on the beautiful coast of St. Simons Island and is close to a few restaurants. The Brunswick Golden Isles Airport is about 28 minutes away from the Hotel. Other close airports include Jacksonville, FL (1 hour 10 minutes) or Savannah, GA (1 hour 23 minutes.) Uber or Lyft are available from all these airports or you may choose to rent a car.
